

# **TOILET GIVE-AWAY PROGRAM**

Kearns Improvement District (KID) is offering residential customers an EPA Water Sense High Efficiency Toilet (HET) to replace their high water using models. This will be Kearns Improvement District 4<sup>th</sup> year of contributing to the community to help save water. This program is part of our goal to reduce per capita water use by 25% by the year 2025.

## **ELIGIBILITY**

Customer must meet the following and any additional requirements listed on the application to be eligible:

- Be a customer of KID.
- The installation address must be in the service of KID
- Must live in a single-family home or business built before 1994.
- Toilet must be installed within 30 days of receiving toilet.
- Application must be approved by KID staff.
- New toilet is for the replacement of existing high-water using toilets only.
- Toilets must be picked up on the date of the voucher. If the toilet is not picked up within 48 hours after the voucher date the toilet will be given to the next eligible person on the list.

## **INSTALLATION**

Homeowners may install the toilets themselves, or they may hire a plumber or contractor to do the job. Owners are responsible for proper installation and associated costs. Installations may be verified by water utility personnel.

## **CREDIT**

- Credits are credits in the form of a credit to customer's account.
- Credit of \$30.00 will be put on customer's account after applications are received and verification on installation is complete.
- Credits will be given on the first-come first serve basis until we reach our goal of 500 toilets.
- Only one credit per household, unless we have extra toilets available.
- Please allow up to 30 days for the credit.
